Rule additions/changes:

Article VI (B) Currently:

B. The executive committee shall have the authority to attend or exclude from participation in the CHURCH LEAGUE any **team**, team member, coach, manager, umpire, or other person(s) whose conduct is considered detrimental to the best interests of the program.

Change by inserting the word “team” right before “team members” to read”:

B. *The executive committee shall have the authority to attend or exclude from participation in the CHURCH LEAGUE any **team**, team member, coach, manager, umpire, or other person(s) whose conduct is considered detrimental to the best interests of the program.*

Article VI (E): Currently:

E. A member church may be expelled from the league by a unanimous vote of the commission, with the representatives from the subject church not voting. In the event of expulsion, one-half of the church's original entry fees may be refunded if the commission so decides by a majority vote.

Change “unanimous” to **2/3rds**

E. *A member church may be expelled from the league by a **2/3 (two thirds) vote of the commission members present**, with the representatives from the subject church not voting. In the event of expulsion, one-half of the church's original entry fees may be refunded if the commission so decides by a majority vote.*
