October 2010 Commissioner's Meeting

A Commissioner's meeting of the Fort Smith Church Baseball League was held on Monday, October 11, 2010 at Christ the King Church.

Meeting was called to order at 5:37 PM by Eddie Norman. Mark Nelson led opening prayer.

March meeting minutes were approved by unanimous vote.

Treasurer's Report

Pat Mickle presented the finance report. Checking account has \$9,462.00. Capital improvement fund has \$16,261.00.

New Business

Rule change: Article X (G) (24) Currently reads *Play is dead when a player enters the pitching circle with both feet and the game ball. At that time any player less than halfway to the next base must return to the base from which he came, unless forced. If the player is over half way to the next base he may advance to said base. The pitcher will be given a chance to make a play on any base when fielding a batted ball within the circle.*

Change to:

*Play is dead when a player enters the pitching circle with both feet and the game ball **OR play is dead once the lead runner is stopped and the umpire has declared the ball dead and called time.** At that time any player less than halfway to the next base must return to the base from which he came, unless forced. If the player is over half way to the next base he may advance to said base. The pitcher will be given a chance to make a play on any base when fielding a batted ball within the circle.*

Motion made by Brent Lewis, with multiple 2nds.

Rule Change: Article X (A) (11) currently reads: *Parents or friends of the game participants shall not interfere with the coaching or umpiring of the game and shall not enter the dugouts or the playing field except in the case of an emergency.*

Change to: *Parents or friends of the game participants shall not interfere with the coaching or umpiring of the game and shall not enter the dugouts or the playing field except in the case of an emergency.*

There will be no photography on the field or from the dugout except by the official league photographer.

Rule Change; Article VII (E) (1) Currently Reads: *Effective January 1, 2006, Churches must pay a \$25.00 per player fee for all leagues to meet to the association's funding needs. The fees are payable to the Fort Smith Church Baseball League in one check per team in each league according to the player totals on the official team rosters. The fees are due by April 15th each year and shall accompany the official team roster. Players added to the roster after April 15th will be assessed player fees to be collected by the league president. Failure to pay fees and turn in completed, official rosters by April 15th will result in the non-complying team not being scheduled and as such will not be allowed to participate for the affected season.*

Change to: ***Effective January 1, 2011, Churches must pay a \$30.00 per player fee for all leagues to meet to the association's funding needs. The fees are payable to the Fort Smith Church Baseball League in one check per team in each league according to the player totals on the official team rosters. The fees are due by April 15th each year and shall accompany the official team roster. Players added to the roster after April 15th will be assessed player fees to be collected by the league president. Failure to pay fees and turn in completed, official rosters by April 15th will result in the non-complying team not being scheduled and as such will not be allowed to participate for the affected season.***
